

## Pre-Contractual Disclosures in Alignment with the UK Sustainability Disclosure Requirements

The Company invests in utility-scale energy storage systems with the aim to provide grid services vital to the integration of renewable energy.

Investment Committee approval is required to confirm that financial, legal, and technical diligence suggests that the proposed transaction is consistent with the Company's investment policy.</p>

The Company also has an external ESG adviser, who is well-versed in industry best practices and ensures the Company's ESG framework and reporting are of a high standard. The Company is constantly monitoring methodological developments to avoided emissions calculations with the intent to align with industry best practice.</p> <p><i>*CO<sub>2</sub>e is a unit of measurement to allow for comparison of different greenhouse gases with different warming potentials. For example, methane is a potent greenhouse gas and absorbs 28x more infrared radiation than CO<sub>2</sub> over a 100 year-period.</i></p>

The Investment Manager's investment, construction and development, and asset performance teams seek to monitor and integrate the Company's health and safety, ESG and investment objectives into its acquisition, construction, and operations model.</p> <p>Additionally, the Investment Manager has put in place policies and procedures to ensure responsible business conduct. These include due diligence processes, 'Know Your Customer' (KYC) checks with ESG provisions, integration of ESG provisions in contracts with key suppliers, and internal training covering issues including bribery, corruption, money laundering and cyber security.</p>
